Sl. No.	The school is directed to ensure that :	
1	The total number of sections of Bal vatika shall be restricted to 3 (1 each for Bal Vatika I, II & III respectively). The total number of sections from classes I to XII shall be restricted to 17. The total number of sections taken together for classes XI and XII should not be more than 1/3 of the number of section allowed including Bal Vtika. Any further increase shall require prior permission of the Board and shall be subject to compliance with the affiliation Bye laws and availability of rooms of >500 sq ft dimensions.	
2	The school has converted regular cubicles into CWSN toilets, but they are very narrow and there is no room for a wheelchair/walker to navigate. The grab bars in CWSN toilets are inappropriately placed, these are not placed on both sides of WC. One towel rod is seen fixed on wall which is not as per guidelines. The signage are temporary. The wash basin is not there inside the cubicle. The CwSN toilets are not seen on every floor. Thus, the school is required to construct the CwSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines within 03 months and submit the compliance.

3	Computer lab does not have appropriate seating facility (stools are there). Hence the school is directed to upgrade computer lab as per SoP issued by the Board and submit the compliance within 3 months.
4	The school has not maintained and upgraded a fully equipped Maths lab as per Board's SoP. Only signage is seen in the videography. Hence the school is directed to setup fully equipped Maths lab as per SoP issued by the Board and submit the compliance within 3 months.
5	All labs (Composite, Physics, Chemistry and Biology) are seen understocked and no sufficient storage facility. Composite does not have appropriate fixture like sinks with water connection, piped gas supply on the demonstration tables. There is no storage facility. Some equipment are seen placed adjacent to side walls which is not appropriate for conduct of practical. All safety features like exhaust fan, fire extinguisher and emergency exit are also not seen in Composite lab and Chemistry lab. Hence the school is directed to upgrade the labs as per SoP issued by the Board and submit the compliance within 3 months.
6	Library is seen understocked and there is no separate reading space for staff. Hence the school is directed to upgrade the library as per SoP issued by the Board and submit the compliance within 3 months.
7	One Transformer is seen within the school campus (ref IC video 0:56). The school is directed to cordon off the transformer to protect reach of the children and submit the videographic compliance within 3 months.
8	The school has provided incorrect EPF registration number. The school is required to provide salary statement and EPF statement for last 3 months.
9	IC has suggested that:- (i) The level of corridor grill on all floors is low as it must be raised up to safety level for the security reasons of the students. (ii) The record keeping like service book, PBR, Attendance register of staff should be well maintained and updated regularly. (iii) More books for senior secondary classes should be procured well in time for Library. (iv) More equipment are needed in science laboratories (Physics, Chemistry and Biology Labs). thus the school is required to comply with the observations of IC.
10	The school shall conduct training of its teachers with CoE Noida within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and

keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.

- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
